Dedicated to working with a team of 5 employees and the established network of collaborators, NRC is continuously working on upgrading its mission and defining strategic priorities for the next period.

The highest decision-making body in NRC is the Assembly, which meets annually. The Assembly adopts the annual work program and approves the annual narrative and financial report from the previous year. The Executive Board approves the strategic plan of the NRC and maintains regular communication with the executive office, ie. the executive director, and in his ranks.

- Collaboration and networking



PROJECTS AND RESULTS FOR 2021

Project name: "Campaign for prevention of violence against women and domestic violence in Roma communities"

Implementation period: 21.07.2021 – 21.01.2023

Donor: funded by UN Women through the Regional Program of the European Union and UN Women "Preventing violence against women in the Western Balkans and Turkey: Implementing norms and changing attitudes"

Budget: 85,021 USD

Location: implemented in 5 municipalities: Kumanovo, Kočani, Kicevo, Prilep and Shtip

RESULTS:

- Prepared promotional materials for the Campaign in Macedonian and Romani language
- Held 2 online trainings for field consultants for effective communication and use of the zoom platform.
- Increased awareness of 394 Roma citizens (men, women, girls and boys) with 425 doorto-door visits in 5 municipalities
- 6 dialogue meetings were held with 83 participants men, women, girls and boys from Roma communities in 5 municipalities Kumanovo, Kočani, Kicevo, Shtip Prilep
- Organized 5 legal counseling sessions for 38 Roma women and girls from 5 municipalities
- Provided legal assistance in cases of gender-based and family violence against women and girls



- Requests for free legal assistance submitted to the Ministry of Justice, sub-regional department Kumanovo






Project name: Organizational development of NRC and improved employability and entrepreneurship skills among Roma, especially among women and youth



RESULTS:

 Online workshops to raise awareness, inform and educate young girls and boys about sexual and reproductive health

- informing 60 young girls and boys aged 17-35 about sexual and reproductive health
- Produced and printed a pamphlet for free legal advice and assistance in a circulation of 150 copies.
- At least 200 free advice and legal assistance to 200 citizens on Health Rights and Social Rights, and strengthened to advocate for their health rights before the institutions
- Produced and printed at least 3 brochures for 3 health protocols in a total of 450 copies
- At least 300 citizens from the Roma community in the Kumanovo municipality informed about 3 protocols from the Ministry of Health for protection during a pandemic for the Roma community, which are closely related to the use of health rights.
- Recorded and produced a short educational video for information on health protection during a pandemic.

INDEPENDENT AUDITOR'S REPORT

We have audited the accompanying financial statements of National Roma Centrum, Kumanovo (in the following text "the Association"), which comprise the Balance Sheet as of 31 December 2021, the Statement of Revenues and Expenses and Statement of Changes in Funds for the year then ended and a summary of significant accounting policies and other explanatory notes.

Management's responsibility for the financial statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with the Accounting Law for Non-profit Organizations and the standards for reporting under the cash basis of accounting. This responsibility includes: designing, implementing and maintaining internal control relevant to the preparation and far presentation of financial statements that are free from material misstatement, whether due to fraud or error; selecting and applying appropriate accounting policies; and making accounting estimates that are reasonable in the circumstances.

Auditor's Responsibility

Our responsibility is to express and opinion on these financial statements based on our audit. We conducted our audit in accordance with the Auditing Standards applicable in the Republic of North Macedonia¹. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance whether the financial statements are free from material misstatement

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgement, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control.

An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.
